NOTICE OF PUBLIC MEETINGS**

The County of Hawai‘i Office of Housing & Community Development (County) is currently planning for its 2025-2029 Consolidated Plan (CP) Program Years with the U.S. Department of Housing and Urban Development (HUD) and the State of Hawai‘i Housing Finance and Development Corporation (HHFDC).

The purpose of the CP is to ensure that jurisdictions receiving federal U.S. Department of Housing and Urban Development (HUD) assistance plan for the housing and related needs of low- and moderate-income families in a way that improves the availability and affordability of decent, safe, and sanitary housing in a suitable living environment.

The County’s CP describes the needs, priorities, funding plans, and program certification requirements over a five (5) year period. The CP is required to be submitted to HUD for the County to receive its annual Community Development Block Grant (CDBG) and Emergency Solutions Grant (ESG) allocations, and for the State to receive its annual HOME Investment Partnerships (HOME), Housing for Persons with AIDS (HOPWA), and National Housing Trust Fund (HTF) allocations.

As required by federal regulations and the County’s Citizen Participation Plan, the County will hold a series of public meetings at the following locations and times. The purpose of the public meetings is to engage with the various communities to hear their views and comments on goals and priorities addressing housing, community development, and homelessness in Hawaii County for the next five years. Input received will assist the County in establishing its goals and priorities for future HUD grants which will be incorporated into the 2025-2029 Consolidated Plan.
